### Directions to Venue – from South - Leave M6 at Junction 26

and follow signs to M58 Skelmersdale/Southport – continue on M58 leave the motorway at junction 3 take the 3rd exit onto Rainford Rd/A570 continue to next roundabout and take the 1st exit onto Ormskirk Rd/A570. After approx. 3 miles turn left into Park Rd/A570. After approx 3 miles, at the bottom of the hill, turn sharp right onto Smithy Lane. The entrance to the hall is at the end of the trees on the left hand side of the lane.  
**From the North – leave the M6 at Junction 27** – take the 3<sup>rd</sup> exit from the roundabout onto the A5209. These rules and regulations are to be read in conjunction with the Kennel Club Rally Regulations S under which this show is licensed. It is the responsibility of everyone entering this show to make themselves familiar with the Kennel Club Rally Regulations, available from the Kennel Club.

1. Judges as listed, reserve judges will be appointed as necessary
2. Prize cards, qualifying certificates and Trophies are sponsored by RallyNews and Rally-O.com
3. Entry is £6 per dog per class
4. Prize cards and Rosettes 1<sup>st</sup> to 6<sup>th</sup> place. Qualifying score of 175 or better in levels 1 to 4 and 180 or better in levels 5 and 6. No prize money is on offer.
5. Competitors to report to the Show Secretary's desk to collect ring numbers, then personally book in at the ring side table then choose a place in the running order.
6. No bitch in season is allowed to compete.
7. The mating of bitches within the precincts of the competition is forbidden.
8. **All dogs must enter and leave the judging ring on lead.**
9. **Dogs must compete in a buckle or snap collar. Collars may have tags on them. Decorations and/or costumes, harnesses, slip leads, check and half-check collars are not allowed.**
10. The committee reserves to itself the right to refuse entries.
11. Not for competition entries will be accepted for dogs aged four calendar months and over. Details of each dog must be recorded on the entry form and must be Kennel Club registered.
12. In the event that the competition is cancelled due to unforeseen circumstances, the society will refund fees, less reasonably incurred expenses. If the show processor has the provisions to do so, competitors will be refunded in the manner in which they had entered the competition, but in any event the society will refund fees within 3 months of the competition date to all those who had entered and requested a refund within 1 month of the competition date.
13. Should a judge be unable to fulfil their appointment the organiser reserves the right to appoint an alternative judge.
14. It is the competitor's responsibility to be available for their class and running order.
15. Should circumstances so dictate the organiser, in consultation with the judges, may alter arrangements as necessary. Such changes will be reported to the Kennel Club.
16. Only dogs of six calendar months of age and over on the first day of the competition are eligible to take part in Level 1 and 2 classes. Only dogs of 12 calendar months of age and over on the first day of the competition are eligible to take part in Level 3 or higher classes or special classes which incorporate jumps or similar exercises.
17. Organisers of Open Rally competitions and Limited Rally competitions may set a capping level on the entries to be accepted in any standard or special class and may decline entries received after the capping level has been reached. State the capping level for each class. The capping level must be set at a minimum of 40 entries received. There is no maximum level at which a cap may be set.
18. A dog must not compete in the same class more than once, including special classes
19. All competitors must personally report to the ring side of all classes entered and book in by marking a list of entries within one hour of the scheduled time for the commencement of the judging of the Class The class lists are to be provided the show management and should be available from the stated opening time of the show. Regulation S(B)3.d.
20. Entry passes are not required to gain entry to the show
21. No person shall carry out punitive correction or harsh handling of any dog at any time within the precincts of the competition.
22. No competitor shall impugn the decisions of the Judge or Judges.
23. After a dog has commenced competing in a Class no substitution of Handler is permitted in that Class.
24. For the duration of the competition and including those in the exercise area, all dogs must be on a lead except when competing or practising prior to competition.
25. Food or toys shall not be carried in the ring or given to a dog whilst under test.
26. The attention of competitors is drawn specifically to the Kennel Club Rally Competition Regulations 9, 17, and 19.
27. A dog cannot be entered in the same class more than once.
28. Once a dog has entered the ring to compete, no further practice may be carried out.
29. A dog must, at the time of entry for the competition, be registered as required by Kennel Club Rules and Regulations in the owner's name (or registration or transfer applied for). In the case of joint registered owners the full name of every registered owner must be given.  
Where an owner makes an entry on behalf of another joint registered owner(s) or where an agent enters on behalf of a single or joint registered owner(s) such person must have the authority and consent from the single or joint registered owner(s) to sign the entry form on their behalf thereby binding them all to Kennel Club Rules and Regulations. In the event of any dispute, evidence of such authority and consent will be required.  
A dog acquired subsequent to entry having been made at a Competition may compete as the new owner's property provided that an application for the transfer has been forwarded to the Kennel Club before the Competition, and the new owner has undertaken to abide by the Regulations and conditions of the original entry form (and in accordance with the conditions set out above).
30. Dogs will be disqualified if proved to have been handled in the class by a scheduled judge's spouse or immediate family, or resident at the same address as a scheduled judge.  
Following discussion between the Chief Steward and the show management and/or a veterinary surgeon, a dog shall be prevented from competing and/or removed from the Competition if it is:
  - a. A bitch which is in season.
  - b. Suffering from any infectious or contagious disease.
  - c. Interfering with the safety or chance of winning of an opponent.

- d. Of such temperament or is so much out of control as to be a danger to the safety of any person or other animal.
  - e. Likely to cause suffering to the dog if it continues competing.  
The circumstances of such a removal shall be recorded in the show Incident Book and submitted to the Kennel Club.
29. Judges' discretion prevails and Judges' decisions are final.
  30. **DOGS IN VEHICLES ON HOT DAYS**  
Your dog is vulnerable and AT RISK if left in a vehicle in high temperatures and even on days considered as slightly warm. Please take care of your dog If your dog is found to be at risk forcible entry to your vehicle may be necessary without liability for any damage caused.
  31. **Welfare of Dogs**  
An exhibitor (or competitor) whose dog is entered at a Kennel Club licensed event should take all reasonable steps to ensure the needs of their dog(s) are met, and should not knowingly put their dogs' health and welfare at risk by any action, default, omission or otherwise. A breach of this Regulation may be referred to the Board for disciplinary action under Kennel Club Rules and Regulations. The use of pinch collars, electronic shock collars, or prong collars, is not permitted at any Rally event licensed by the Kennel Club. This shall apply at the venue and within the precincts of the competition.
  32. No modifications may be made to the Schedule once published except by permission of the Board of the Kennel Club which must be followed by advertisement in the Canine Press if possible
  33. **Animals in Event**  
No animal other than one officially entered shall be brought into the precincts of a competition during its continuance, except any dogs registered to assist the disabled, or dogs required for educational or instructional purposes or by permission of the Board. However, at the discretion of the host organisation, a dog brought to the show by a spectator may be admitted into the precincts of the competition, with the proviso that those in charge of the dog sign a declaration confirming the dog is free from disease and that the dog will be kept under proper control at all times.

## ELIGIBILITY AND SCHEDULE OF CLASSES

### Classes at Rally Competitions

A competition host may stage one or more special classes not conforming to the standard class tests set out in Annex C of the Regulations. Such classes must contain the word 'Special' in the title of the class, and shall not count towards progression, titles or awards in standard competition classes.

### Levels

Rally handler/dog teams compete in their lowest eligible class from level 1 to level 6. They may also compete at the subsequent level. Progression to the next level does not require either wins or places. Progression is dependent upon gaining three excellent scores, under three different judges, or six qualifying scores under four different judges. Levels 1 – 4 have a qualifying score of 175 out of 200. Levels 5 & 6 have a qualifying score of 180 out of 200. Scores equivalent to these qualifying scores (or greater) earned at Limited Rally competitions do not count towards Progression, Rally Level Titles or Excellent titles. In all levels a qualifying score 190 or above equates to an excellent score.

### Eligibility

When entered for a competition, a dog must be entered in a standard class at the level for which it is eligible. The dog may also, if desired, be entered in up to two additional classes, one further standard class at the next level up, if scheduled, one additional special class, if scheduled, or two additional special classes. A dog may be entered in special classes only, up to a maximum of 3 classes. Special classes do not count towards progression.

### Level 1

- Open to dogs which have not achieved a Level 1 or Level 1 Excellent Title.

### Level 2

- Open to all dogs which have achieved a Level 1 or Level Excellent Title, except those that have achieved a Level 2 or Level 2 Excellent Title. Dogs eligible for and entered at Level 1 may also enter at this Level.

### Level 3

- Open to all dogs which have achieved a Level 2 or Level 2 Excellent Title, except those that have achieved a Level 3 or Level 3 excellent Title. Dogs eligible for and entered at Level 2 may also enter at this level.

### Level 4

- Open to all dogs which have achieved a Level 3 or Level 3 Excellent Title, except those that have achieved a Level 4 or Level 4 Excellent Title. Dogs eligible for and entered at Level 3 may also enter at this level.

### Level 5

- Open to all dogs which have achieved a Level 4 or Level 4 Excellent Title, except those that have achieved a Level 5 or Level 5 Excellent Title. Dogs eligible for and entered at Level 4 may also enter at this level.

**Level 6** - Open to all dogs which have achieved a Level 5 or Level 5 Excellent Title. Dogs eligible for and entered at Level 5 may also enter at this level.

# \*FITdogs Privacy Policy - GDPR

Let's get this GDPR requirement out of the way. We will keep this in the simplest form possible!

## 1, What information do we gather?

We have to record the names and basic details (height, breed etc) of the dogs that are entering into our Rally Competitions.

We also record the names of the owner/handler(s) of the dogs entered into our Rally Competitions, along with their contact details – postal address and email address.

We do NOT record credit or debit card details of entries made via “With Your Dog Rally” as that service is a ‘third party’ and subject to their own Privacy Policy.

## 2. Where do we get the information from?

All information that we record is provided by the entrants to our Rally Competitions via the official Entry Form or through “With Your Dog Rally”.

## 3. Why do we record information?

We record the information as stated in paragraph 1 to:

- a. Ensure only those that have paid the Entrance Fee actually participate in any particular ‘level’ at a Rally Competition
- b. Establish who is entered in any particular ‘level’ at the relevant competition, award scores and qualifications attained
- c. Maintain a record (in abbreviated form) of the qualifiers in every ‘level’ at all Rally Competitions according to Kennel Club Regulations
- d. Assist in maintaining ‘control’ at the venue for Health and Safety purposes
- e. Verify qualifications and placings at previous Rally Competitions

## 4. How do we record information?

We retain printed Entry Forms and associated records for a maximum of one year from the date of the relevant Rally Competition, following which they are destroyed by ‘shredding’.

Records of results from each level at a Rally Competition are retained digitally on a removeable disc, stored securely and in encrypted form for a maximum of five years. These records comprise the dogs names, their ‘score’ and the level/venue.

## 5. Unsolicited contact

The only time we may contact an entrant to our Rally Competitions will be in response to a query or to confirm or clarify specific details.

We NEVER send out marketing emails, spam or junk.
