If selected for the SE&EA Team you must commit to attending Crufts on Thursday 5th March 2020, competing in your level and acting as a reserve for the level above, to attend at least two of the first three training days and to attend the final training day on 23rd February when the courses are known.

Training Dates are Sundays 12th and 26th January, 9th and 23rd February.

Individuals will need to pay their own expenses for training and Crufts and be willing to assist in team fundraising activities. Funds raised will go towards hall hire costs, also to assist team members with the costs of attending Crufts. Team members will receive 2 free passes into Crufts on Thursday 5th March, one the yourself and one for a helper.
